Chairman's report

Most of us had hoped that 2021 would be less challenging than the year that preceded it but sadly this was not to be. It is well known that the lockdowns over the past two years have impacted on the physical and mental well-being of many and increased the need for services such as those offered by Temcare.

Temcare Programs

It is gratifying to report that Temcare is one of the few agencies that has been able to maintain the provision of services in some form to needy families during this past year in spite of Covid. Some services have needed to be delivered via phone or Zoom, there have been periods where staff have been required to work from home. and staff team meetings have also needed to occur electronically on some occasions. We are grateful to all staff for their patience, creativity and commitment to Temcare's clients during this challenging period. Thanks too to all of our volunteers and mentors who have managed to maintain contact with their clients. Your determination to serve is wonderful. We praise God for the numerous clients that have written to describe the blessing and encouragement they have experienced via Temcare staff, and also for the emergence of new service opportunities that have arisen during this past year. It has been frustrating that service delivery has at



times been constrained due to a lack of volunteers and so in September we held a successful Zoom event entitled 'The Importance of Christian Volunteering'. This resulted in several enquiries from prospective volunteers.

We continue to be grateful to the Federal and State Governments for financial assistance via Jobkeeper, Business Support and other programs. With the easing of restrictions our primary funding body has been able to resume our pre-Covid funding levels and for this we are grateful. Churches and individual donors have continued to amaze us with their generosity and we are thankful for our service partners (ie. Prison Fellowship, CYC) for their ongoing support. Urgent requests for specific client needs have on occasions astonished us by exceeding the amount required. Nevertheless, we expect to face an operating deficit this next year.

Staff News

We continue to be grateful for Neville's leadership, especially during the difficult Covid period. We are also fortunate to have such a cohesive and happy staff and volunteer team. Sadly, Mary has left her Accounts Officer role but we welcome Jessie as she moves into this important position in January. King-Wei joined the team as a second Youth Worker (complementing Simone) in September and has settled in well. Klaudia will commence maternity leave around early March and so a replacement Respite Care worker will be required.

Board Changes

There have been several Board changes during 2021. Sadly, Geoff Francis vacated the Chair position and retired from the Board in November after several years' service. His quiet, steady and wise leadership was greatly appreciated and his fellowship will be greatly missed. Gordon Hoen was appointed Vice Chair and I welcome his support and enthusiasm in my new position as Chair. Gordon rejoined the Board in February after a brief time away. David Desmond and Trent Osborne also joined the Board bringing with them a breadth of business, IT and other experience which has already proven invaluable. Their enthusiasm and vitality are infectious and their love of the Lord is evident to all. We thank George Morgan and Sue Diggles for their preparedness to continue on the Board. Their contribution and extensive knowledge of Temcare and its history is invaluable and especially appreciated by newer members.

In November a Strategic Planning morning was held and facilitated by an external consultant. In addition to Board members, Neville (as Manager) and Naomi (in her role as a Team supervisor) also attended and provided valuable input. This event provided the Board with the opportunity to reflect, take stock, and discuss goals and priorities over the next three years. The spirit of the morning was very positive and the outcomes provide greater clarity for us all as we move forward into a new year and beyond.

The Future Ahead

In spite of Covid-19 Temcare has, with God's blessing, continued to meet its goal of extending 'the love of Christ to those who are struggling to cope with life'. We know that God will honour those whose faith is in Him, and bless our efforts to be a light in a fallen world by assisting clients to experience new and brighter futures. As Jesus said:

Manager's report

About Temcare

Christian Brethren Community Care Limited [CBCC], or Temcare, is a Christian welfare agency associated with the Christian Community Churches of Victoria and Tasmania [CCCVAT]. In its various forms, Temcare has been serving families and individuals in Victoria since approximately 1968, and presently operates from an office in Ringwood North.

Temcare provides a range of services for vulnerable families and individuals within the Victorian community, and primarily within the Eastern and South Eastern regions. These services are grouped under the following program areas:







Respite Care for children Mates Mentoring for

adolescents

Family Services support for parents



Temcare provides programs that seek to:

- i. Strengthen core intrapersonal and interpersonal life skills for family members.
- ii. Facilitate responsive and positive relationships between parents and their children.
- iii. Reduce sources of stress for children, adolescents and family members.



In terms of the latter, and only with the clear permission of the person, Temcare endeavours to assist parents, children and adolescents to:

- i. Develop a personal relationship with Jesus Christ.
- ii. Become connected to and established in a local supportive church of their preference.
- iii. Grow in their Christian faith journey.

These programs are geared towards:

- i. Enhancing an individual's emotional and social development.
- ii. Supporting parents to provide appropriate levels of care for their children.
- iii. Improving social / emotional / educational / outcomes for children and adolescents.
- iv. Facilitating a person's interest in exploring matters of the Christian faith.

Temcare's programs integrate evidence based welfare practice with clear Christian values and a vision to see people experience a life-changing relationship with Jesus Christ and to become connected with a local church of their choice. The programs are staffed by a combination of professionally qualified welfare practitioners and appropriately recruited and assessed volunteers who are committed in their Christian faith.

During 2021, Temcare's programs were again significantly constrained by the COVID-19 pandemic and the associated government restrictions on what could be provided. On this occasion, it was our MATES mentoring program that seemed to be most affected. Many adolescents were reluctant to engage with their mentors, either 'in-person' or 'online', despite the concerted efforts of mentors and staff to engage with them. This dynamic was consistent with reported observations made by various professionals working within the welfare field about a general trend within the adolescent community relating to deteriorating mental health and disengagement from social networks.

Our Respite Care program was not as affected, although a number of cancellations occurred at various times because of; positive COVID cases, adults and children being exposed to potentially COVID positive contacts, or both carers and parents being hesitant to proceed with the scheduled respite because of the pandemic.

The number of respite care placements [314 nights and 84 actual placements1 and MATES mentoring 'catchups' Г101 involvina 168 davs1 for the year were therefore severely impacted.

The Family Services Staff continued to support vulnerable families and individuals throughout the shutdowns. This was in sharp contrast to other family support agencies, whose services tended to withdraw or limit the delivery of services during this period. We were also pleased to introduce a 'Play Therapy' component to our Family Services program following Natalie's training in the area.

It is a testament to all of our staff and our available volunteers, that they remained in contact with our clients and supported them in whatever way possible.

We were also fortunate to be able to run our MATES mentoring camp in March, and our Family Camp in April. The following statistics continue to reflect very different numbers to previous years. Despite this however, referrals continued to be made to all of our programs. We also continued to support a significant number of parents, adolescents and children in our various programs. This has given us confidence that the community views Temcare as a legitimate welfare agency that can provide relevant services to people and families in need.

During 2021, Temcare employed eight staff in varying capacities, ranging from 38 hours to 15.2 hours per week. These staff provided a range of services for families and individuals residing across the wider Metropolitan area.

In 2021, we experienced a number of significant staff movements. King-Wei Khoi commenced with us in September as a Youth Worker in the MATES program, where his primary focus is to provide casework support for male adolescents. Natalie Walton shifted to a part-time role with Temcare in mid-September, so that she could commence a part-time role with Play Therapy Australia. Naomi Manderson assumed the role of Team Leader in September and now has primary responsibility for supervising all clinical staff. In addition, staffing hours were increased throughout the year for Rachel Chan and Simone James to enable them to meet the growing demands of client needs in their respective programs.

We also advertised 2 part-time positions during 2021; one to cover the gap in our

Family Services program due to Natalie's move, and the other to cover the impending departure of Klaudia Charles who will be on maternity leave from late February until November 2022. Unfortunately, we have still not been able to fill the Family Services position but are hopeful that we will soon find a successful applicant for the Respite Care Co-ordinator role.

Temcare is very fortunate to have a Board comprising people who are committed to Temcare's Mission Statement. We are very grateful for the service they have provided over many years, and particularly during 2021. A special thanks to Geoff Francis who, in late November, completed a long stint as a Board member and 12 months as Board Chair. We have also appreciated the long-time service of George Morgan and Sue Diggles, and the more recent involvement of Gordon Hoen [a returned Board member], David Desmond and Trent Osbourne. Each person provides a level of expertise that is complementary and we are blessed to have them and to also have Tim Morse at the helm.

Stories from 2021

We have been so encouraged by the support shown by our supporters throughout the year. In early 2021, a partner church provided the funds to purchase a laptop for one of our special clients. The mother in question was so grateful. Later in the year another of our partner churches funded the cost of special orthotic shoes for a young client. This was such a blessing for him and his mother.



At various times during the year, our supporters have donated various items for our clients. We are so thankful to have people willing to do so. Durina we adolescent clients Naomi Manderson and Simone James [MATES] mentoring staff] decided that they wanted to and encourage special people. call to our supporters for funds to purchase care packages for them. The response of our supporters to our 'Care Package' program for adolescents was wonderful. Within a week of the request being made to support our vulnerable adolescent clients with special 'care packages', \$3,230 was received. We used these funds to purchase some lovely items for them. Thank you for your generosity.

These are some of the comments we received when we passed on the care packages to our adolescents.

'OH MY GOSH I LOVE THIS' (in response to each item one of our teens pulled out of the bag)

'Thank you so much for the gifts I can't wait for the next camp I miss u guys sooo sooo sooo much and am looking forward to it'

'I just read the card and thank you so much I love you guys so much I'm so blessed to have you's in my life' 'That's really kind and thoughtful of them, pass on our thanks (to the donors)', 'There's a lot of good people in the world' As recently reported, a special fundraising event occurred in late October to support a single mother whose car required significant repairs. Even though we only requested \$3,000, \$6,650 was donated in one day. This meant that the mother was able to meet the total cost of the car repairs without using funds she had set aside for her children's education costs for 2022. Whilst we were staggered at the size and speed of the response, the mother could not believe the generosity of strangers towards her and felt undeserving of such kindness.

Rachel, her Temcare support worker, simply told her that it was God's doing, as He was showing her His grace and kindness through His people.

This is what Naomi had to say to everyone who helped her out:

"Hi. I am Naomi. A lot of you donated money to help me fix my car. I have 4 kids; 12, 9, 5 and two year old. This is my car that you wonderful people helped repair because I was not going to be able to afford it. And I just wanted to say thank you to each and every one of you and hope you have a wonderful Christmas and a great new year and I wish you all the best for your future and I just cannot thank you all enough from my heart . Yeah, you are all incredible, amazing people and it just, and I can't even explain, I don't have enough words for it, so yeah thank you so much."

We were also very grateful for the support provided by Edge Community Church, Canterbury Gardens Community Church, Neuma Church, Full Gospel Assembly Box Hill, and Belmore Road Church of Christ for our Christmas giving program.

\$7,500 was donated for the Christmas gifts and approx. 75 food hampers were provided. As a result of their generosity, we were able to provide every parent, child, and adolescent with a \$50 gift voucher, and every family with at least one Christmas hamper. We have included some photos of clients receiving their Christmas hampers. What a privilege and joy it is to share the generosity of God's people with others in the hope that they will begin to understand the amazing Grace of our Heavenly Father.

'Be very patient because they [people thinking about volunteering] need to understand that some of these kids come from very rough backgrounds ... You know without that connection between the love of them and who they were looking after, and also to the love that God gives us, I think if you haven't got that right then I think you know, I think you're gonna be in for difficult times ahead ...' 'My [Temcare] mother would say if you strongly believe that you've been called by God to do what you are about to do then go for it ...

'My [Temcare] mother said, hello beautiful [to me when I came out of court], let's go home ...'

'My [Temcare] mother said to me [on her deathbed]. Anthony, I love you ... you know folks, without your help and support, children like me, we would never have a chance to live. All we want is to be loved, to have a safe and secure home ... my question to you folks is how much love have you got to give? Temcare is a good organisation ... my advice to you folks is just to love people, love us kids, and be patient with us. The rewards will be there for you.'

'Never under-estimate

the role they [carers] can play in a child's life ... You may never see the breakthrough while they are in your care ... '

'[my expectations when I first commenced having a child in my care] I was sort of more concerned about not scaring my wife ... I just wanted [respite care] to go smoothly ...'

'The challenges came as we had our own kids because it was difficult balancing all the kids' needs ... I found it really challenging on how to split the time [between the children] and how I could meet their needs ...' 'Just doing activities where we can all participate ... we just do activities together ... just the consistency and showing and inviting the people into your daily life, event and birthday parties. Making them feel very important ...'

'If someone can commit and provide that consistency and show love and really believe in that child, then do respite ... I would be totally lost without what Andrew [his carer] has done in my life ... I often ask myself the question, where would I be if he wasn't around ...'

'The first few visits [with the young person] were really challenging ... all she wanted was consistency ... once I had that fifth visit it was a different story ... we got there eventually ... every fortnight I committed myself to seeing this person ... that person needed that consistency, that reliability, that security ... just being myself, just mucking around ... having a bit of fun because that kid did not know what fun was'

'I would like to encourage all the viewers out there to just, if they feel that I am not quite sure how I am going to do this, just go with what you feel is in your heart, and just give it a try and speak to the team. It doesn't matter what your background is ...'

'I would like to recommend to anyone who is out there to contact the Temcare team. They are very helpful and will give you all the help and support and all the necessary information for you to follow what God has put in your heart ... follow the desire that God has put in your heart'.

'We just have felt really blessed to be with these children and have them in our lives and be able to just, yeah, just make an impact, have a lot of fun, show them experiences they might not have had before, and you know, give them love and Christ into their lives, and we definitely would recommend it to anybody.'

'Yeah, you gotta step out of your comfort zone and it is a bit uncomfortable at times but that's what's worth it because you're actually making sure that these children really see life how it can be in a different kind of way.'



Respite Care

Short-term respite care provides a muchneeded break for families while offering children a loving and caring environment. It is available for children, aged between 0-15 years, for 1-2 nights every 6 weeks, although these arrangements are negotiable depending on the availability of the respite carer and the needs of the family. Temcare connects families-in-need with Christian carers. Children can be placed with couples, singles or families, and wherever possible and appropriate, siblings will be

kept together. All Temcare respite carers are comprehensively assessed and are required to obtain a current 'Working with Children Check' and to submit to a 'National Criminal History Check'.

Family Services

Integrated family support is available for parents and/or their children, and seeks to address parenting difficulties and those factors that contribute to stress and breakdown within the family unit. Professionally trained staff members work closely with professional networks and supportive local churches to provide families with stability, safety and care.

Within a supportive environment, a monthly support group ['Women of Hope'] explores important personal and parenting

issues that impact on women. A 'Play Therapy' program is also available for a limited number of children.

At various times during the year, education programs are conducted to assist parents with relevant parenting matters. A family camp is also run for families already involved in Temcare's programs.

the way we supported our clients in 2021 (staff and clients) were all just trying to and survive. However, as we pass another year of dealing with the various waves of covid and all the associated stresses 2021. With our high vaccination rates, life is there is always the risk of covid throwing another curve ball, like the new variant Omicron that has emerged in recent weeks, and despair. However, as Christ followers, we need not fear or despair as those who have no hope for our home is not this world and we have another home to look forward to. Our desire as staff at Temcare is to give this same message of hope to our clients and help them build new futures in a covid normal world with Christ as the foundation.

One of the clients whom I've helped to build a new future is a single father who has a 5 year old son. This father has struggled to access NDIS service for his disability due to a lack of understanding of the system and how to navigate it. With Temcare's support, the client was able to see a neuropsychologist so he can be assessed for acquired brain injury due to long term substance abuse and an injury to the head and back he sustained as a victim of an armed robbery. By God's grace and providence, this client was able to be assessed and diagnosed with an acquired brain injury within a couple of weeks and an NDIS application submitted and approved a couple of weeks later. Having access to NDIS funding and services will assist this client to have a better and new future with his son after many many years of struggle and suffering.

It was another challenging year for the respite care program. Constant changes to the restrictions meant we had to adjust the way we delivered our program many times. Luckily, the respites that were happening pre pandemic restrictions were allowed to continue. This was a welcome allowance for the families I work with. Once again, the carers commited themselves to supporting their respite child even if it meant an outside catch up instead of a home stay, or a zoom call to keep in touch. Having this regular contact was a huge help for the mums and something to look forward to for the kids who had lost a lot of their usual outlets.

One mum reported that her pre-teen son, Adam, was having a lot of behavioural problems since he couldn't play basketball due to the restrictions. When his carer heard this, he took it upon himself to regularly take Adam to play basketball with him at the local park. The mum was so grateful and reported that Adam's behaviour improved drastically, which made the whole household enjoy each other a little better.

Another example of a carer being creative in their role is Sue who came up with many inventive ways to keep the 2 kids she cared for entertained when there was little they could do outside of the home. She had bake off challenges, an array of crafts, face painting, and many other games. The kids were always so eager and excited for their respite weekends and I can see why.

Even if things were a little challenging at times, I found that we all tried our best

to build a new future for the Temcare families. We continued to support them through the programs we delivered, advocated for them when they couldn't do it themselves, showed empathy and kindness when it was most needed, and we made sure the family didn't go without because they couldn't afford things that many of us take for granted, such as fresh food and access to electronic devices.

We are truly blessed with the amazing carers that God brings to us here at Temcare. Without them the future of some of the kids would be challenging but with them it is truly a bright light. What the carers do for the kids through simply showing them God's love and giving them undivided attention is invaluable.

In the year ahead I am excited to see many Christians become interested in the Respite Care program and I can't wait to see new relationships and futures flourishing over the years ahead.

Mates Mentoring

Temcare connects an adult Christian volunteer mentor with a young person [aged between 10 & 15 years] for regular organized activities. The volunteer brings his or her life experiences to the mentor/ mentee relationship and seeks to assist the young person with; general life skills, forming positive social networks, exploring constructive lifestyle options, and making positive career choices.

All Temcare volunteer mentors are comprehensively assessed and are required to obtain a current 'Working with Children Check' and to submit to a 'National Criminal History Check'. The Mates program also provides individual support for vulnerable and at-risk youth from 2 qualified Youth Workers.

An annual camp is organized for adolescents and their mentors. This event provides opportunities for mentors and mentees to further consolidate their relationships and to explore matters of faith for those interested in doing so.

Who would have thought that this year was going to be another challenging year? I'm sure no one knew that heading into 2021. However, one thing I have learnt is that when required, we are able to pivot and come up with ways of still servicing our clients and trying our best to meet their needs.

I decided that another tough year meant that I needed to really think of a new way to encourage our clients, particularly our teenagers. I was getting feedback that they were struggling, so I decided to come up with the idea of providing a "care package" specifically tailored to them. We did a call out to our wonderful supporters who also seemed to capture my vision and went above and beyond, and we were able to provide some wonderfully encouraging gifts in the packages. We put in bible studies, chocolates, games, smelly things for the girls, and socks for the boys. Our precious teenagers understood that we were thinking of and praying for them.

What is also wonderful, is how encouraging this is for us as workers. When we have an idea and put a call out, it's so humbling and exciting to see the generosity of our supporters come through time and again. Please know that this encourages us hugely and helps to remind us that our work is valuable.

I have continued to support the volunteers, adolescents and some of their mothers who have been struggling. One family I have been supporting has a young person who is part of the Mates Program. She has been matched with an amazing mentor, and it's perfect timing as her mother is struggling with cancer and all the complications that go with this. The adolescent also has two younger siblings with complex diagnoses that makes home life even more challenging.

We had continued to provide fresh food hampers as her immune system was compromised, and she was so appreciative of this. She often sent messages of appreciation saying how exciting it was to get the hamper, as it then created a chance for her to cook with her teenage daughter and have chats whilst doing this. She said that it also has created a family tradition where every Sunday they would sit down and have a meal together as a family. I was also able to encourage the family that we were often holding their family up in prayer. She so appreciated our support and prayers.

So, as well as building new futures, we are also helping families build new family traditions. This is so encouraging and so valuable for the family unit. It was also something I didn't even think about when organising this for the family. I remember a saying I heard one time from a Christian speaker – **"you do what you can do, and God will do the rest"**. Multiple blessings came from a simple idea.

Although this year has had its challenges, it has also been so encouraging to be creative in our outreach and interaction, and to find ways to stay connected and the big thing for me is the encouragement and generosity of our supporters. It's been truly humbling and such a blessing.

I'm so looking forward to the year ahead and with such anticipation, praying that we can continue to sow and build new futures for our adolescents and families.

2021, what I year! I feel like I started last year's report in a very similar way too. Little did we know that this year would turn out looking frustratingly similar to last year. As once again we quickly became intimate with zoom. Once again we were dropping off food on people's doorsteps, hoping for a brief interaction through their flyscreen. And once again I was reminded of just how much we need our God, when our life is full of so much uncertainty.

This year, God has put on my heart time and time again the verse from Esther (4:14) which says 'perhaps you were created for such a time as this'. I have found incredible reassurance in the fact that the God of the universe could have put my life and your life into any period of history or times to come but he chose to put us here 'for such a time as this'. Would we have chosen this for ourselves, possibly not, but knowing that this is where God has chosen to place us should give us huge amounts of confidence to step into every interaction believing it's a divine appointment! And we have seen many divine appointments this year.

This year, once again, I have been in awe of the resilience shown by the teens I work with. And their desire to build new futures for themselves. While it seems that the whole of Australia was on pause again, it was incredible to see the steps that these young people kept taking forwards. One of my clients who has only attended 2 weeks of school in the last two years has just decided she wants to enrol at an alternative school and will start back in term 1 of next year. One of my other incredible clients has just taken a huge step towards independence by applying for her own private rental as an 18-year-old. She's also about to start her Certificate 4 in Youth Work next year, which is an incredible achievement given she left school in year 9 and had to come back later to complete a Certificate 2 in Adult Education. She is also in the process of applying for part time jobs and slowly building up her learner driving hours.

I'm also regularly blown away by the faith of some of the young people in our program. One of my young clients had just had his mum pass away after a long health battle and I asked him how he was doing. He responded with such precious faith. He said he knew his mum was in heaven with God and so he was doing okay because he would get to see her again soon.

This year was also an exciting time for the youth work program, as we expanded our team to welcome a new male youth worker on board. As our waitlist consisted of many young males who do not have a father present, we believe this will be an incredible step moving forward in being able to provide a positive male role model for these teens.

Whilst knowing the impacts that have come from such a short time of support, I am confident that there will be more places to grow in the future for these families.

Although my time here has been short so far, I am looking forward to making an impact with my clients by encouraging and supporting them to reach their potential. This is a new chapter for all of us. New challenges are ahead of us and the only way to get through it is to pray and give it into God's hands.



Financial Report

Temcare continues to be primarily reliant upon financial donations from individuals, churches and Charitable Trusts to fund our various welfare programmes. The decision to be thus reliant enables Temcare to provide flexible services to the community that are not constrained by the stipulations associated with formal funding arrangements. This is unique within the 'welfare world'. It also means however, that Temcare is dependent on the generosity of individuals, churches and charitable trusts that share our vision.

We continue to be very grateful for the generosity displayed by a consistent group of financial supporters, whose sacrificial giving has enabled us to continue our ministry. This was particularly important during the 2020/21 financial year, as our primary funder was unable to continue its usual level of funding due to the impact of COVID shutdowns. To some degree, this reduced level of funding was ameliorated by Federal and State government financial assistance for agencies impacted by COVID. The result of these factors meant that CBCC experienced a significant operating loss for the 2020/21 financial year.

The second half of 2021 has been more positive however, as we have seen the return of funding from our primary funder, including the reintroduction of the comatching arrangement for all donations made to Temcare. We have also seen God use His people to give generously towards a number of special fundraising events.

During 2022, we will again be looking to our Heavenly Father and His people to provide the financial resources we will need to serve our clients. We hope that you will see the potential for supporting vulnerable families and the opportunities this support provides us as an agency to demonstrate our Heavenly Father's grace and mercy to those in need.

Report on the Financial Report

Opinion

We have audited the accompanying financial report, being a special purpose financial report, of Christian Brethren Community Care Limited (the company), which comprises the statement of financial position as at 30 June 2021, the statement of profit or loss and comprehensive income, statement of changes in equity and statement of cash flows for the year then ended, notes comprising a summary of significant accounting policies and other explanatory information, and the directors' declaration.
